These prices are effective as of June 1st, 2019, and are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire.

However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you selected arrangements such as direct cremation or immediate burial, you do not have to pay for embalming you did not approve.

Terms of payment

Payment is due in full prior to services being rendered. We accept Visa, Discover and MasterCard. Payment plans are also available through Lending USA.

Direct Cremation

Includes the basic services of a funeral director and staff, the collection of the decedent from a hospital or coroner's office, sheltering the decedent in refrigeration for up to 5 days including the day the decedent was brought into our care, an alternative cremation container, transport to crematory, crematory fee, plastic utility urn, alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard. You may provide your own container as long as it meets state and crematory regulations. If you provide your own container, the charge for direct cremation will be \$995

Basic Services of Funeral Director and Staff

\$995

This fee is for our basic services and overhead. It will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation.) This fee includes coordinating all cremation arrangements, registering the death certificate in the county California where the death occurred, obtaining the health department disposition permit, and obtaining certified copies of the death certificate on your behalf.

- Preparation of Decedent Sheltering of decedent in refrigeration; first 5 days **\$150**
- Sheltering of decedent in refrigeration; daily charge beyond 5 days **\$50 (per day)**
- Removal of battery operated implanted devices **\$50**
- Surcharge for decedents exceeding 300lbs and up to 500lbs
(we cannot handle decedents over 500lbs) **\$250**

Transportation

- Transportation of decedent from a hospital or Coroner's office (normal business hours) **Included**
- Transportation of decedent from a private residence (at time of passing) **\$250**
- Transportation of decedent to crematory **Included**
- Receiving decedent from another funeral home (Includes: Discounted Service of the funeral director staff and overhead, Transfer of the remains to the funeral home, refrigeration and care) **\$500**

- Forwarding deceased to another funeral home (*Includes: Discounted service of the funeral director staff and overhead, Removal, Processing of Death Certificate, Refrigeration. DOES NOT INCLUDE: Embalming, Transportation to other funeral home, casket or merchandise.*) **\$600**

Shipping

- Packaging and mailing of cremated remains within the US by USPS Priority Mail Express **\$100**
- Delivery to your residence or cemetery (*30 miles*) **\$200**
- Unwitnessed sea scattering (*Los Angeles or Orange County*) **\$150**
- Collecting cremated remains at Rose Cremation Services **No Charge**
